## MEDICAID REDETERMINATION

Redetermination is a review of eligibility for Medicaid, All Kids, SNAP or cash assistance. Eligibility for Medicaid and All Kids must be reviewed at least once a year. The state of Illinois decides whether a client meets the rules to keep getting benefits.

If your eligibility is being reviewed through IMRP, you will get a letter in the mail. **It is very important that you complete the form and return it on time.** Your case will be canceled if the State does not hear from you by the due date or if you do not provide all the information. If your case is canceled, you will no longer get medical benefits.

## RE-DETERMINACIÓN DE MEDICAID

Re-determinación es una revisión de la elegibilidad para Medicaid, All Kids, SNAP o asistencia de dinero. La elegibilidad para Medicaid y All Kids debe ser revisado por lo menos una vez al año. El estado de Illinois decide si un cliente cumple con las reglas para seguir recibiendo beneficios.

Si su elegibilidad se está revisando a través IMRP, usted recibirá una carta por correo. **Es muy importante que complete el formulario y devolverlo a tiempo.** Su caso será cancelado si el estado no escucha de usted antes de la fecha de vencimiento o si usted no provee toda la información. Si usted cancela su caso, usted no va recibir beneficios médicos.
