Illinois Medicaid Managed Care Program Changes

You may receive a notice regarding your Medicaid coverage. Starting January 1, 2018, managed care in Illinois is changing. The new, Medicaid program is called **HealthChoice Illinois**. The new program will not change your benefits.

Family Health Network and Aetna Better Health Patients

If you are currently enrolled in Family Health Network or Aetna Better Health, you will receive notification of changes.

Cook County Residents:

- Family Health network (FHN)- transition to CountyCare Health Plan effective November 1, 2017.
- Aetna Better Health- transition to CountyCare Health Plan effective January 1, 2018.

Collar County Residents (Residents outside Cook County):

- Family Health Network (FHN)- transition to Illinicare Health effective January 1, 2018.
- Aetna Better Health- transition to Meridian Health Plan effective January 1, 2018.

What does this mean for you?

If you wish to stay with your assigned health plan, you do not need to do anything. If you do nothing, you will be insured by your new health plan and be able to continue to use the Children's Clinic for your medical and dental care.

If you DO NOT want to stay with your assigned plan, you have 90 days from the transition date to change your health plan.

If you wish to change from your current Medicaid Health Plan, the Children's Clinic accepts **ALL** the Medicaid Health plans listed below:

Pacientes de Family Health Network y Aetna Better Health

Si usted está actualmente inscrito en Family Health Network o Aetna Better Health, usted va a recibir notificación de cambios.

Residentes del Condado de Cook:

- Family Health Network (FHN)- la transición a CountyCare Health Plan estará efectivo el Primero de Noviembre del 2017.
- Aetna Better Health- la transición a CountyCare Health Plan estará efectivo el Primero de Enero del 2018.

Residentes del Condado de Collar (Residentes fuera del condado cocinero):

- Family Health Network (FHN)- la transición a Illinicare Health estará efectivo el Primero de Enero del 2018.
- Aetna Better Health- la transición a Meridian Health Plan estará efectivo el Primero de Enero del 2018.

¿Qué significa esto para usted?

Si desea quedarse con su plan de salud asignado, no necesita hacer nada. Si usted no hace nada, usted va a continuarse cubierto por su nuevo plan de salud y usted va a poder continuar viniendo a la clínica de niños (Children's Clinic) para su cuidado médico y dental.

Si usted **NO QUIERE** quedarse con su nuevo plan de salud, usted tiene 90 días a partir de la fecha de transición para cambiar su plan de salud.

Si usted desea cambiar su plan de salud, la clínica de niños (Children's Clinic) acepta todos los planes en lista abajo:
